ANY REQUEST FOR ASSISTANCE FOR AND ANY FORM OF CONTACT WITH WOMAN FROM MY OWN TRIBAL GROUPS THAT IS ARCTICUS BLANCUS PROTECTED THE RESOLUTION A/RES/47/135 ARTICLE II STATES THAT: Persons belonging to minorities have the right to establish and maintain, without any discrimination, free and peaceful contacts with other members of their group and with persons belonging to other minorities, as well as contacts across frontiers with citizens of other States to whom they are related by national or

ethnic, religious or linguistic ties. SO THE ISSUE IS THAT SOCIETY BY THE POLISH LAWS PROHIBIT NATURAL TRIBAL RELATIONSHIP TO ESTABLISH AND MAINTAIN TRIBAL CONTACT. AND THE POLISH LAWS PREVENT ALL TYPES OF PROTECTION AND SUPPORT UNDER THE BASIS THAT TRIBES PRIOR 966 DO NOT HAVE RIGHT TO FORM OWN TRIBAL AND SUBTRIBAL GROUPS AS THE POLAND WAS CONQUERED BY THE PIAST FAMILY THAT IS VIOLATION OF SAME RESOLUTION ARTICLE III THAT STATES Persons belonging to minorities may exercise their rights, including those set forth in the present Declaration, individually as well as in community with other members of their group, without any discrimination.

(2) No disadvantage shall result for any person belonging to a minority as the consequence of the exercise or non-exercise of the rights set forth in the present Declaration. POLISH GOVERNMENT HOWEVER DOES NOT BELIEVE THAT NATURAL TRIBES HAVE RIGHT TO MAINTAIN ITS IDENTITY AND THAT IS VERY STRONGLY DISCOURAGED BY PRESENT POLISH REPUBLIC CULTURE. RESULTS ARE ALMOST COMPLETE EXTINCTION OF ALL MALES FROM ARCTICUS BLANCUS TRIBES LEAVING ALL FEMALES DICTATED GENOCIDE OF ALL HOMONATURAL TRIBAL GROUPS SO A TO REPUBLIC OF POLAND DOES NOT LOOSE ITS ECONOMIC AND TERRITOTIAL INTEGRITY OVER NATURAL TRIBES OF THIS CLIMATE.

LAWS OF REPUBLIC OF POLAND REMOVED TRIBAL RIGHTS IN 966 AND EVER SINCE THE IMBALANCE OF GENDERS IN MY TRIBE (ARCTICUS BLANCUS) GROWS. I HAD DONE STUDY IN 3 CONSECUTIVE DAYS AND THE RESULTS SHOW IMBALANCE OF 198 FEMALES FROM ARCTICUS BLANCUS TO 1 MALE FROM ARCTICUS BLANCUS.

ALL THAT DUE TO LAWS PROHIBITING NATURAL MARRIAGES WITH FEMALES FROM TRIBE THAT IN RESULT CAUSE HETERO TRIBAL MARRAIGES AND BY NATURAL MECHANISM FROM HETERO TRIBAL MARRIAGES THE BIRTH RATE OF MALES IS NEAR ZERO (0) SO THE NATURAL BALANCE OF MALES TO FEMALES SINCE 966 HAS BEEN IN DECLINE AND TODAY MY TRIBE IS FACING EXTINCTION.

i HAD FILLED 5 SEPERATES COMPLAINT. I HAD RECEIVED AN EMAIL REGARDING FIRST THREE COMPLAINTS THAT I HAD FILLED ON THE 11TH, 14TH, 24TH OF MARCH THAT THE ISSUE I DESCRIBE IS UNCLEAR AND DOES NOT FALL IN TO THE RESPONSIBILITY OF THE PROSECUTION OFFICE OF REPUBLIC OF POLAND. i HAD ALSO FILLED ANOTHER COMPLAINT EXPLAINING IN DETAILS THE ISSUE OF EXTINCTION DUE TO RESTRICTIONS IN NATURAL MARRIAGES AND LACK OF PROPER REPRODUCTIVE HEALTH SUPPORT FROM THE MINISTRY OF HEALTH. I HAD ALSO TRIED TO LIMIT THE MILITARY DRAFT OF MALES FROM NATURAL CLIMATIC TRIBAL GROUPS THAT ARE IMBALANCED IN THE NUMBER OF MALES TO FEMALES OR ARE JUST ENDANGERED AS THEY DO NOT HAVE THE MINIMUM VITAL POPULATION MVP THAT IS REQUIRED TO SUSTAIN REPRODUCTION AND PREVENT GENETIC RELATIONSHIP ISSUE OF PROCREATION WITH TOO CLOSE RELATED MEMBERS OF THE TRIBE, HOWEVER I HAD NOT RECEIVED THE REPLY YET

MAJORITY OF THE POPULATION OF POLAND IS MULTI TRIBAL GROUPS. THE MOST DISTINGUISHED GROUPS THAT AFFECT AND PREVENT TRIBAL RELATIONSHIPS FOR ARCTICUS BLANCUS ARE THE SOUTHER SLAVIC TRIBES OF DARK BLOND, DARK BROWN AND SOME BLACK HAIR TRIBES THAT SETTLED IN POLAND THAT HAVE COLONIZED NORTHERN TRIBES OF THE ARCTICUS BLONDUS AND IN THE RESULT THE ARCTICUS BLANCUS TRIBES THAT HAVE LIVED IN PEACE ON THE TERRITORIES OF THE SO CALLED BLONDUS TRIBES THAT ARE TODAY THE TERRITOIRES OF THE CENTRAL AND NORHTER POLAND.

MAJORITY OF ALL GOVERNMENTAL POWER IN THE REPUBLIC OF POLAND THREE BRANCHES ARE NON ARCTICUS BLANCUS. WEBSITE OF THE HOUSE OF REPRESENTATIVES OF THE REPUBLIC SHOWS NO MALE MEMBERS OF THE ARCTICUS BLANCUS TRIBAL GROUPS. THE ARCTICUS BLONDUS REPRESENTATIVES THAT SERVE THE PARLIAMNET ARE PRESENT IN THE NUMBER OF MORE THAN 90. WITH SEVERAL MALES, HOWEVER THEYDID NOT REPLY TO ANY OF THE OFFICIAL PARLIAMNET PETITIONS AND PERSONAL LETTERS TO IMPLEMENT CHANGES TO SAVE THE ARCTICUS BLANCUS TRIBE FROM NEAR ZERO MALE POPULATION AND RESTORE TRIBAL COMMUNICATION AND PROTECTION RIGHTS.
