6 **Ethnic Repatriation and Relocation Centers**

7 for the **Arcticus Blancus** - Indigenous polar ethnic group

10 1. Eugenix P.S.A. is consistently developing a program that allows for the repatriation and relocation
11 of Arcticus Blancus an indigenous polar ethnic group to its natural arctic territory from non-indigenous
12 climatically territories that persistently deteriorated Arcticus Blancus ethnic phenotype and due to multi-
13 climatic reproductive and religious relationships further endanger the existence of the Arcticus Blancus
14 indigenous polar ethnic group.

16 2. Eugenix P.S.A. has sent documentations to Norwegian Embassy in Warsaw to initiate procedure
17 involving repatriation rights secured by the United Nations ILO convention C169 titled - "Indigenous and
18 Tribal people Convention" ratified by Norway, Denmark and Germany.

20 3. Eugenix P.S.A. has also sent a complaint to the Polish Constitutional Tribunal to complaint about
21 lack of the legislative protections and fiscal fairness for the Arcticus Blancus indigenous polar ethnic
22 group that was first native group in arctic and sub arctic, but since 966 due to creation of the Polish
23 Kingdom and later Polish States is in danger of extinction. The court case signature that has been
24 assigned to the founder of Eugenix P.S.A. Krzysztof Ireneusz Pawlak complaint is: TK SYG
25 WER.451.185.2025.

27 4. Eugenix P.S.A. is very optimistic about the future and it hopes to achieve successes thru its
28 communications with the states that had ratified C169 convention and with the state of Poland
29 Constitutional Tribunal Court and hopefully other organizations.

31 5. Eugenix P.S.A. is also very hopeful to interest foreign non-indigenous states from the *Rafaltic* and
32 *Aquatic* territories in *Eugenix P.S.A. Antarctic Ice Removal Program* and *Eugenix P.S.A. Polar*
33 *Geomagnetic Dams Construction* that will help to restore Earth's magnetic circulation that lowers the
34 UV light penetration and in-sum with magnetic field properties recirculates earths water between the
35 northern and southern magnetic polar territories in environment protected by the increased magnetic field
36 that repels-refracts sun' excessive UV light;

38 6. Eugenix P.S.A. magnetic field increased protection allows magnetically attracted water molecules
39 to: increase atmospheric moisture, increase clouds and rain cycles in dry regions, move water across
40 continents, pull and circulate water from the oceans, lower earth's and oceans temperature that in result
41 helps to cool atmosphere, lands and oceans that allow botany and biology to thrive free from droughts,

46 7. Eugenix P.S.A. is planning to open *Arcticus Blancus Ethnic Relocations and Repatriations*
47 *Centers* in every state where members of the Arcticus Blancus group live, however due to lack of
48 acknowledged responsibilities and responses from the states located in the arctic territories members of
49 the United Nations that have various views towards indigenous protections the Eugenix P.S.A. plans to
50 open centers only in the most needed locations based on the circumstances of the members of the
51 Arcticus Blancus ethnic group and based on the legal and financial reach of the Eugenix P.S.A. tight to
52 the assistance that Eugenix P.S.A. hopes to receive from the Kingdom of Norway, Denmark and the
53 Republic of Poland.

55 8. The finances received from the Kingdom of Norway and Denmark Eugenix P.S.A. will open
56 *Arcticus Blancus Ethnic Relocations and Repatriations Centers* in the states located between the 42°
57 North and 42° South such as Gaza-Palestine or Israel where the situation of the Arcticus Blancus
58 members with and without medical conditions is critically dangerous due to presence of:

60 a. Human exploitation and trafficking.
61 b. Military conflicts.
62 c. Natural disasters.



63 d. Dangerous climate.
64 e. Rest of factors.

66 9. The finances received from other individual governments for example from the Republic of
67 Poland will be spent on domestic *Arcticus Blancus Ethnic Relocations and Repatriations Centers* in the
68 states funding the centers unless otherwise allowed by those governments. For information on
69 repatriation and relocation rules that will priorities members of the Arcticus Blancus in correct order
70 based on varying situations please read *Eugenix® Full-Ethnic and Semi-Ethnic Reservations Admittance*
71 *Guidelines*.

73 10. The Repatriation and Relocation Centers located regardless of the funding source will support
74 indigenous members with programs focused on the readiness of the members of the Arcticus Blancus
75 community to repatriate to the Arcticus Blancus indigenous territory and with programs that support
76 other everyday needs of the indigenous individuals and families not limited to the following:

78 a. Ethnic Repatriation Programs.
79 b. Ethnic Relocation Programs.
80 c. Ethnic Financial Assistance Programs.
81 d. Ethnic Employment Programs.
82 e. Ethnic Education Programs.
83 f. Ethnic Housing Programs.
84 g. Ethnic Climatic and Reproductive Health Programs.
85 h. Ethnic Psychological Health Programs.
86 i. Ethnic Dietary and Non-Dietary Supplies Programs.

88 11. Eugenix P.S.A. is very optimistic about the future regardless of the present situation in the world
89 showed and not showed in the public and social media and it hopes that other indigenous communities
90 begin to rethink their philosophy with their indigenous affairs in-mind to protect their indigenous groups
91 connection with their indigenous species and nature for evolutionary climate repair and environmental
92 protection and clean-up.



94 12. Eugenix P.S.A. hopes to open at least one *Arcticus Blancus – Relocation and Repatriation Center*
95 in every capital of every state member of the United Nations with additional branch offices in European
96 Economic Area, European Union, Russian Federation, United States of America and Canada that have
97 active 24/7 telephone line ready to help indigenous members that are outside of the reach of main and
98 branch centers anywhere on earth.
