5 **DRAFT OF PLAN OF RETURN OF ALASKA**
6 **TO THE INDIGENOUS ARCTICUS BLANCUS**
7 **POLAR CLIMATIC HAIR GROUP**
8 **BY THE UNITED STATES OF AMERICA**

11 *United States of America has been established on various climatic territories*
12 *that are a part of symbiosive ecosystem of various ethnic climatic groups*
13 *with corresponsive climatic territory of land and water.*

15 1. *Arcticus Blancus is one of the groups on whose territories a state of United States of America has*
16 *been established. Eugenix P.S.A. understands that at the time of colonization of the territories of Alaska*
17 *and other states the science was not sufficient to understand the climate symbiosive concept of ethnic*
18 *climatic groups to ethnic climatic lands and waters.*

20 2. *The scientific knowledge is now at the benefit of Arcticus Blancus and other indigenous groups,*
21 *finally able to prove key aspects of understanding of the concept of planetary division of climates and*
22 *symbiosed ethnicities established by the tilt of the planet, periods and strength of the darkness and*
23 *lightning, movement and reach of atmospheric heat, waters and winds.*

25 3. *In the next few hundred years humanity will certainly explore new concepts that Eugenix P.S.A.*
26 *has already prepared for longer study such as the circulation of water by the circulation of earth's*
27 *magnetic field. Humanity will also deeply benefit form Eugenix P.S.A. Antarctic Ice Removal Program*

32 4. *Arcticus Blancus norther hemisphere indigenous territory is located from 62°45" North up to the
33 north pole in 360° circle that accounts to 28,333,333 km2 that is approximately 5.55(5) % of the earth's
34 surface. Arcticus Blancus southern hemisphere indigenous territory is located from 62°45" South up to
35 the South Pole in 360° circle that also accounts to 28,333,333 km2 that is approximately 5.55(5) % of the
36 earth's surface.*

38 5. *Arcticus Blancus natural indigenous white polar hair pigmentation has developed due to
39 inhabitation of the above-mentioned climatic territories for very long time before any signs of
40 civilization. This type of pigmentation cannot be reproduced and is very unique and very visible in lots of
41 polar indigenous mammals that are exposed to polar nights and days, as Arcticus Blancus was before
42 descended to subarctic when the ice begun to break and travel across the northern hemisphere polar
43 regions became too dangerous with purpose to explore the reasons for the slow collapse of the northern

47 6. *State of Alaska like the rest of the Arcticus Blancus territories is currently govern by non-
48 indigenous governments. In case of Alaska its United States of America. Arcticus Blancus like other
49 indigenous groups is attached to its polar territory not only by history, but by its climatic hair-skin-eyes
50 phenotype-phototype. Arcticus Blancus like other polar indigenous species of mammals, birds and fish
51 will never take non-polar territories for permanent occupation and habitation because we are deeply
52 connected with polar climate and polar species-based diet, we eat polar fish and no other fish can suit
53 our dietary and religious believe system as we are connected with polar species and constantly exchange
54 information about the land and water and all that happens in the indigenous polar territories.*

56 7. *Last information that we had received was from the polar bears, that had informed us thru tik-tok
57 videos that the ice is preventing them from getting to all shores of the Arctic and something must be done,
58 for example a mission with polar bears to the Antarctic to verify if they can sustain themselves in the
59 ecosystem of the southern species. We and polar bears believe that it must be verified by the bears.
60 United States of America like a lot of colonies established state has not ratified United Nations
61 Convention UN ILO C169 that protects the rights of indigenous groups and despite lots of protections*



62 *given to the native Americans non has been given to the Arcticus Blancus indigenous polar tribes, nor it
63 was ever legislated by the United States Congress or President to study the indigenous groups and colony
64 residents territorial naturality to the various climatic zones of the United States of America.*

66 *8. Arcticus Blancus to the benefit of the United States of America is an indigenous polar group of
67 which territorial attachment is easy to notice and prove. Although we are not planning to leave other
68 groups on the ice alone, as some think, we can only part take as much as our bodies, god, and finances
69 allows us as we are very endangered meaning there is very few of us and we are focusing our time of
70 writing as much as we can about the climate repair that will benefit the earth a home to different
71 individual climatic ethnicities.*

73 *9. We ask that you review our wish for the return of our lands and water back to us as soon as
74 possible so we can also help our Arcticus Blancus indigenous persons around the world to have its own
75 place back to come home and sleep like we used and fish like we used to while our plans to fix the climate
76 are looked over by interested states that also includes the United States of America.*

78 *10. Arcticus Blancus must also obligate the United States of America State of Alaska public and
79 private entities that hold any real estate that includes all public and private structures and
80 infrastructures that an obligation is developed and enacted in the Arcticus Blancus portion of the state of
81 Alaska that all public and private structures and infrastructures are subject to mandatory deconstruction
82 and decommission cash or gold bonds paid to later designated Arcticus Blancus Banking entity to secure
83 all potential damages to the Arcticus Blancus natural indigenous territories for the damages resulting in
84 the abandonment of privately and publicly build structures and infrastructures that Arcticus Blancus
85 prefers not to have.*

87 *11. Bonds are a security to the Arcticus Blancus in case Arcticus Blancus will have to hire out a
88 contractor to deconstruct and decommission any single one and even all private and public structures
89 and infrastructures that are currently established by non-indigenous colony established residents and
90 citizens of the United States of the America.*

92 *Other tax obligations for the use of land, use of natural resources that includes mandatory deposits for
93 plastics and other petrochemical based products that pose a permanent harm to the Arcticus Blancus*
