17	PETITION FOR THE PROTECTIONS OF INDIGENOUS AND TRIBAL PERSONS

19	1. I kindly ask the European Union Parliament to propose to all European Union member
20	states a ratification of United Nation International Labor Organization Convention C169
21	"Indigenous and Tribal Peoples Convention" of (1989) to bring to all EU member states
22	protection of indigenous occupations and resource based economic protection that provided thru
23	indigenous fishing, farming, forestry on indigenous lands and waters of European Union,
24	provided and explained in UNILO C169 convention.

27	LACK OF INDIGENOUS AND TRIBAL PROTECTIONS

29	2. EU extensive policy over fishery and fish industry matters without protections set by the
30	UN ILO C169 convention prohibits indigenous and tribal persons and groups from ability to
31	sustain own persons and groups thru unfair competition among EU member states that provides



32	no protection for indigenous and tribal industries that related to their indigenous occupations
33	such as farming, forestry and fishing, fish processing, fish transport, fish sales done historically
34	for thousands of years by the indigenous and tribal persons and groups in their corresponding
35	waters.

38	BENEFITS OF INDIGENOUS AND TRIBAL PROTECTIONS

40	3. Protections set in UN ILO C169 allow all indigenous and tribal persons and groups for
41	traditional fishing, farming, forestry and other indigenous and tribal occupations that will
42	always relate to own indigenous and religious believes. Upon ratification by all European Union
43	member states convention C169 all indigenous and tribal groups and persons of EU will have
44	right to live by its indigenous and tribal religion-based occupations and diets that protect those
45	groups from extinction of their indigenous economic rights with prosperous indigenous and
46	tribal family ethnic community life.
