4 **EUGENIX P.S.A. EMPLOYMENT GUARANTEES IN THE GEOMAGNETIC**
5 **DAMS CONSTRUCTION AND ANTARCTIC ICE REMOVAL PROGRAM FOR**
6 **SHAREHOLDERS INDIGENOUS AND SHAREHOLDERS COINDIGENOUS**
7 **ETHNIC GROUPS.**

10 1. Eugenix P.S.A. will allow ice share purchasers to use own subcontractors and use chose
11 subcontractors from the Arcticus Blancus non-indigenous contractors of lower subarctic in particular
12 Arcticus Bluntus and all Coarcticus groups. and lower subarctic indigenous companies for the development
13 and operation of fleet technology for the ice removal program only. Geomagnetic dams will always stay
14 under the Arcticus Blancus own indigenous employment with the use of Articus Blondus, Arcticus Blendus
15 and their co-indigenous Coarcticus Burgundus and Brunettus from A, B, C 1-4 as stated in the publication
16 Eugenix® Ethnic Hair Quantum for Ethnic Work Predisposition.

18 2. Eugenix P.S.A. will allow ice share purchasers to subcontract the above listed ethnic groups for the
19 development and operation of fleet technology for the ice removal program only if all Eugenix P.S.A.
20 ethnic terms are followed by those contractors especially rules that relate to protection all individual
21 ethnicities from any kind of ethnic genocide by hetero-ethnic marriages with Arcticus Blancus or any other
22 ethnicity other than own kind.

24 3. Eugenix P.S.A. with the Arcticus Blancus reserves the right to terminate, shorten, modify, any long-
25 term contract-permission to conduct business with its shareholders due to any ethnic and economic injustice
26 reported to Eugenix P.S.A. or Arcticus Blancus by its shareholders, other subcontractors or any other type
27 of reporting individual, group, entity, etc

29 4. All workers, contractors, firms, suppliers and other entities will be added to Internal Ethnic Union
30 of workers, contractors and suppliers that will be allowed to benefit from all types of ethnic collaboration
31 and further work opportunities. Union will help to connect all companies and subcontractors with



shareholders to provide Ethnic Contracts or long-term employment for all nonindigenous nationals having residence in the arctic and subarctic states that allow them to get jobs related to ice removal program with aimed to connect and revive nonindigenous nationals own indigenous life in their indigenous Rafaltic and or Aquatic climatic territories with goal to restore climate and establish ecological and sustainable future in their native lands.

5. The above employment limits represent a total number of contracts to be performed across all shareholders. Eugenix P.S.A. will keep track of contracts and advise shareholders on total number of contracts all listed ethnicities have completed or signed for with all shareholders in individual states.

6. Shareholder states should utilize own ethnic work force from own states before reaching to neighboring states for same ethnic workforce. Shareholders should also remember that their own ethnic members live abroad in the arctic and subarctic as nationals of arctic and subarctic states that are included in the above plan to help join back broken up individual ethnicities thru own cooperation.

7. Keep in mind that all work to be performed in the Antarctic related to the Ice Removal Program is highly health deteriorating due to “gene shredding” therefore it should be done only by the Arctic and Coarctic ethnicities as mentioned above in the percentages set above not to discriminate able ethnicities. All other work related to Ice Removal Program that relate to Fleet Welding and Steel production should be done by the shareholders own and neighboring states.

8. Arcticus Blancus reserves up to 66.66% of all works related to the Geomagnetic Dams to own indigenous ethnicity. To all other ethnicities as specified above Eugenix P.S.A. and Arcticus Blancus reserves at least 5.55% of work on both Geomagnetic Dams Project under the Eugenix P.S.A. and Arcticus Blancus indigenous management.

9. All percentage values refer to monetary contract values signed by shareholders with individual ethnic groups listed ethnic subcontractors regardless of wage rates, hours worked, and technology used by individual subcontractors of various ethnicities listed.
