## Factual Summary

HOLLYWOOD PRODUCTION OF HETEROETHNIC/HETERORACIAL ROMANCE A CAUSE OF ETHNIC PORNOGRAPHIC GENOCIDE. HOLLYWOD THAT PRODUCES AND MARKETS HETERORACIAL AND HETEROETHNIC MOVIES INCREASE THE IDEA THAT HETERORACIAL AND HETEROETHNIC REALTIONSHIP ARE NORMAL AND TRADITIONAL RIGHTS RESERVED BY THE RESOLUTION A/RES/260/III AND OTHER RESOLUTIONS SUCH AS A/RES/47/135 AND A/RES/54/4 THAT SECURE RIGHTS TO ALL ETHNIC AND RACIAL GROUPS RIGHTS TO PRESERVE OWN HERITAGE AND ETHNIC CHARACTERISTICS CAUSE THAT ACTORS AND ACTRESSES ARE COMING TO HOLLYWOOD TO OBTAIN ROLES IN MOVIE PRODUCTION THAT MAKES IT EASY FOR THE WORLDWIDE PORNOGRAPHIC INDUSTRY IN CALIFORNIA AND ALL OVER THE WORLD TO INTRODUCTE VARIOUS ETHNICITIES AND RACES TO HETEROETHNIC AND HETERORACIAL PORNOGRPAHY ESPECIALLY WOMAN FROM ENDANGERED ETHNIC ARCTICUS BLANCUS GROUP THAT IN PART BY HETEROETHNIC AND HETERORACIAL PORNOGRAPHY AND MOVIES IS PRSENTED AS A GROUP THAT DOES NOT HAVE MALES AND FEMALES THAT CARE ABOUT OWN ETHNIC RIGHTS TO LIVE, HAVE FAMILY AND BE PART OF SOCIETY THAT PARTICIPATES TO EMBETTER HUMANITY. HOLLYWOOD THEREBY CREATES AN ENVIRONMENT THAT PRAYS ON DISCRIMINATION THAT CAUSES MASS RAPE OF WOMAN THAT EXPECT TO GET MOVIE ROLES BUT END ON THE PORNOGRAPHY CASTING COUCH. I RECOMMEND THAT ICC SETS LAWS TO BAN ALL HETERORACIAL AND HETEROETHNIC MOVIES AND HELP TO BAN ALL HETEROETHNIC AND HETERORACIAL PORNOGRPAHY INDUSTRY ON THE INTERNET AS THIS IS A GENOCIDE ON ETHNIC MINORITIES THAT IN COEXISTANCE WITH NATIONAL BIRTH AND MARRIAGE RESTRICTIONS FOR HOMOETHNIC RELATIONSHIPS CAUSE EXTINCTION IN ETHNIC GROUPS SUCH AS ARCTICUS BLANCUS OF NATURAL WHITE ARCTIC BLOND HAIR. ALL EXISTING MOVIES THAT HAVE ANY HETERORACIAL AND HETEROETHNIC SEXUAL OR ROMANTIC CONTENT SHOULD BE LABELED WITH MESSAGE THAT ETHNIC GROUPS HAVE RIGHT UNDER VARIOUS RESOLUTIONS THAT SHOULD BE LISTED IN THE MESSAGE. MOVIE MESSAGE SHOULD ALSO INCLUDE INFORMATION THAT EXPLAINS THAT THE PRODUCTION REPRESENTS HETEROETHNIC/HETERORACIAL CONTENT CAN CAUSE HARM TO ETHNIC GROUPS ENDANGERED BY LOW BIRT RATE AND TOTAL POPULATION NUMBER. OTHER OPTIONS SHOULD BE CONSIDERED AS WELL. IN ADDITION ANY CASTING PRIOR COMPLETE BAN OF HETEROETHNIC/HETERORACIAL PRODUCTIONS OF ROMANTIC, SEXUAL AND PORNOGRAPHIC CONTENT SHOUL BE MADE IN ATTORNEYS OFFICE AND THE CONTRACTS SHOULD EXPLAIN THE RISK TO ALL PARTICIPATING ETHNIC AND RACIAL GROUPS THAT THE MATERIAL DOESNT PROMOTE HOMOETHNIC/HOMORACIAL LIFE AND CULTURE AND THEREBY CAN CAUSE GENOCIDE AND EXTINCTION OF A SPECIFIC GENDER AND WHOLE ETHNIC GROUP AS IT IS NOW WITH THE ARCTICUS BALANCUS THAT HAS LESS THAN 1 MALE FOR EVERY 200 FEMALES THAT ARE BY HETEROETHNIC RELATIONSHIPS PROMOTED BY INSTITUTIONS SUCH AS HOLLYWOD AND PORNOGRAPHY GENETICLY NOT UNIFORMED TO THEIR ORIGINAL FENOTYPE THAT CASUES CONGENITAL DISORDERS.
