Factual Summary

ARCTIC MEN EXTERMINATION NOTICED.

THE VATICAN BASED ROMAN CATHOLIC CHURCH FROM YEAR 966 CONTINUOUSLY STANDS AGAINST NATURAL RIGHTS OF CLIMATOGENIC ETHNIC GROUPS INHABITATING TODAY'S REPUBLIC OF POLAND AND OTHER ARCTIC AND SUBARCTIC STATES BY RELIGIOUS LAWS THAT:

1. PREVENT BIRTHS IN CLIMATOGENIC ETHNIC GROUPS TO OWN WOMAN OF OWN CLIMATOGENIC ETHNIC GROUPS BY;
2. RELIGIOUS LAWS THAT ALLOW ONE MEN OF CLIMATOGENIC ETHNIC GROUPS HAVE MARRIAGE AND REPRODUCTION TO ONLY ONE FEMALE OF CLIMATOGENIC ETHNIC GROUP THAT WITHHOLDS BIRTH RIGHTS SECURED BY RESOLUTION 260 IN CASE OF NATURALLY OCCURING IMBALANCE IN THE NUMBER OF FEMALES TO MALES IN SPECIFIC ETHNIC CLIMATOGENIC TRIBAL AND SUBTRIBAL GROUPS THAT CAN OCCUR AND REQUIRE LESS NUMBERED MALES HAVE CHILDREN WITH GREATER NUMBERED FEMALES OF SAME OWN CLIMATOGENIC ETHNIC GROUP
3. ELIMINATE MEMBERS OF ETHNIC CLIMATOGENIC AND ETHNIC GROUPS CHARACTERISTICS PROTECTED BY 47/135 ARTICLE 2-4 BY;
4. RELIGIOUS LAW THAT ALLOWS A MEN OF ANY CLIMATOGENIC ETHNIC GROUP HAVE MARRIAGE AND REPRODUCTION TO A FEMALE OF ANY DIFFERENT CLIMATOGENIC ETHNIC GROUP THAT CAUSES SERIOUS BODILY AND OR MENTAL HARM TO MEMBERS OF ALL CLIMATOGENIC ETHNIC GROUPS PROHIBITED BY UN RESOLUTION 260 THAT RESULTS IN CLIMATOGENIC ETHNIC TRIBAL AND SUBTRIBAL GROUPS INTERNAL GENDER IMBALANCE, EXTINCTION CONGENITAL DISORDERS SUCH AS HETEROTRICHOSIS, HETEROCHROMIA, DIABETES, INFERTILITY, SLEEP/WAKE DISORDERS, MENTAL DISORDERS, ETC.

I ASK THAT INTERNATIONAL CRIMINAL COURT INVESTIGATES THIS REPORT TO FULL EXTENT OF THE INTERNATIONAL LAWS AND REGULATION AND ASK VATICAN AND THE ROMAN CATHOLIC CHURCH OF POLAND TO STATE ITS POSITION TO THIS COMPLAINT. EUGENIX REPRESENTS OWN TRIBAL HERITAGE AND RIGHTS AND INTERESTS OF TRIBAL HERITAGE AND RIGHTS OF THE ARCTICUS BLANCUS CLIMATOGENIC TRIBAL GROUP UNDER RESOLUTION RES 54/4 ARTICLE 2-7.
